HOLMES COUNTY SCHOOL BOARD WORKSHOP April 4, 2017

Following an Executive Session for the purpose of Bargaining, the Holmes County School Board held a Workshop on Tuesday, April 4, 2017 at 5:00 p.m. in the Board Room at 701 East Pennsylvania Avenue in Bonifay prior to the Regular Session. Board Members present: Sid Johnson – Chair, Shirley Owens – Vice-Chair, Rusty Williams, Alan Justice and Wilburn Baker. Also present: Superintendent Terry Mears, Board Attorney Jeff Goodman, Administrator Buddy Brown and Finance Officer Kelly Leavins.

Discussion included:

- A) Assistant Principals Internal Review Process
 - ➤ Ed Leadership and passing FELE would be qualifications
 - > Timeline for receiving qualifications
 - Interview board to include three people outside the district
 - ➤ Readvertise positions in-house
 - > Years in position of APs to be considered
 - ➤ Budget for increased AP salaries; projected savings from all proposed changes in personnel; calculations and difference in amounts of increase between APs
 - ➤ Timeline for advertising positions within the next month
- B) Advertising of K8 School Principal and two AP Positions
 - Request for AP positions to be hired in-house
 - > Principal position to possibly be advertised openly per Supt. Mears pending recommendation
 - ➤ New identification code for new K8 School
 - > Selection committee to conduct interviews
 - > Possible hiring APs based on new qualifications pending approval
 - Possibility of a future meeting/public hearing to adopt new AP qualifications
 - > Transferring of teacher/AP positions to new K8 school
 - Current BES school grade in regards to past performance of current faculty, staff and Principal at BES
- C) Advertising of District Transportation /HR/Communications Director
 - ➤ Director's position to aid in the transfer of students and personnel to the new K8 School and communcations, including media, developing flyers, etc.
 - > Open advertising of position
 - ➤ Qualifications knowledge of school system, transportation and dealing with the public
 - ➤ Considerations of new K8 School pending staffing changes
- D) BES and BMS Facilities
 - County interest in BES facility \$250,000 offer
 - ➤ Attorney Jeff Goodman discussed:
 - Options for liquidation /disposal of these types of properties
 - Flexibility under Florida Statutes
 - Resolution would have to be passed by the Board
 - Florida Statute requirements for educational facilities
 - Considerations for best interests of the public
 - ➤ BMS Facility
 - Possibility of moving District Office to BMS facility
 - Construction of maintenance facility
 - Maintenance cost once vacated
 - Upgrades required to BMS facility
 - Possibility of facilitating contact with the City about current District Office property and structures – Rusty Williams agreed to initiate contact with the City

- County Commissioner Bobby Sasnett made comments concerning County purchasing BES facility to become a One-Stop Shop for the County
- Considerations of Fair Market Value for BES facility
