Executive Summary

BES houses 802 students. We are located in a small rural community that sits off I-10 midway of Tallahassee and Pensacola, Florida. The current population of Holmes County is 19, 717 (2013) and Bonifay is 2,772 (2013). Over the last three years our student body has remained, on average, the same. We've had eight retirements in the last three years, Lucianne Brown, Deborah Goolesby, Julie Short, Jennifer Braxton, Kathy Brazile, Brenda Rich, Jackie Jackson, and Janet Powell).

As of this year, we are mostly departmentalized in third grade and completely departmentalized in fourth. Two third grade classes are self-contained. Our efforts to work with the community we serve are involved. For instance, we have a detailed pick up policy for our students in which we provide passes (4) to family members in order to create cohesiveness among family and staff, as well as, maintain a nice flow during release times every afternoon. The challenge we face is parents/family forgetting their pass. In this case, they are directed to the front office where they are given a written pass by the receptionist to present at the pick-up gate. Not only is cohesiveness and flow maintained, but safety for our large student body is heightened even though we are a small rural area. We can never take the safety of our students for granted. T

School's Purpose

The school's purpose is to provide a safe, civil environment, staffed with highly qualified teachers, where excellence in student achievement is the goal. Our vision is to educate today's students for tomorrow's world. We believe in establishing an environment where students feel safe, loved, and respected throughout the day.

Teachers utilize various holidays to identify and celebrate the varying cultures within the classrooms. For example, some classrooms have a yearly holiday luncheon in which they invite parents to join their children for a holiday feast within the classroom. Families are encouraged to bring their favorite holiday dish and children share about their favorite family tradition and how they may celebrate. Also, our Art and Music teachers provide various opportunities to study and learn about various cultures throughout the year. In addition to this, various administration and staff are assigned at multiple duty posts throughout the school on a daily basis. We maintain consistency with the individuals at each post to allow the staff the opportunity to get to know the students and develop a relationship with them by seeing them daily. Also, we escort all non-school personnel throughout the school for visits and conferences to maintain security. This helps to provide a safe and secure environment for all students. Also, each K-4 students' backpack has been equipped with a label displaying the child's name and bus #, if necessary. The buses have also been detailed with a magnetic sign with their number fixed on the inside wall of the bus. If a student gets away from his teacher he can find his bus or a staff member will know where to take him.






