The Holmes County School Board held a Public Hearing on Monday, AUGUST 1, 2022 at 5:05 p.m. in the Board Room at 701 East Pennsylvania Avenue in Bonifay.

**C. RESOLUTION TO ADOPT TENTATIVE MILLAGE FOR 2022-2023**

**Whereas**, the School Board of Holmes County, Florida, did pursuant to chapters 200 and 1011, Florida Statutes, approve tentative millage rates for the fiscal year July 1, 2022 to June 30, 2023; and

**Whereas**, at the public hearing and in full compliance with Chapter 200, Florida Statutes, the Holmes County School Board adopted the tentative millage rates for fiscal year 2022-2023 in the amounts of:

The total millage rate to be levied is less than the roll-back rate by -1.05 percent.

**Resolved**, That the District School Board of Holmes County adopted each tentative millage rate for the fiscal year July 1, 2022 to June 30, 2023 on August 1, 2022 by separate vote prior to adopting the tentative budget. – Kaci Johnson moved to approve the resolution, second by Shirley Owens which passed unanimously. 


